POLICIES, RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT ("AGREEMENT"). THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND DEPRIVES YOU OF THE RIGHT TO SUE THE OWNER(S) OR EMPLOYEES OF COUNTRY PET RANCH AND PET SITTERS RECOMMENDED BY COUNTRY PET RANCH, AND RELATED PARTIES. DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ AND UNDERSTAND IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT.

In consideration for your Pet(s) ("Pet(s)") being permitted to COUNTRY PET RANCH or be served by Pet Sitters recommended by COUNTRY PET RANCH, you agree to all of the policies, procedures, release, terms and conditions set forth below. The following Agreement will apply to COUNTRY PET RANCH, employees, owners, agents and representatives (collectively referred to as "COUNTRY PET RANCH").

1. All Pets must be current on Rabies, Distemper, Parvo and Bordetella vaccinations (required for dogs only); be current on heartworm and flea and tick preventatives be current on Rabies, FVRCP vaccinations (required for cats only); meet all municipal and state licensing and other requirements;

be in general good health and free of ticks and fleas; be non-aggressive towards other dogs and people; not be aggressive over toys or other items; be leashed or otherwise secured when entering and exiting COUNTRY PET RANCH (dogs and cats)

2. Photo, Video, Website and Social Media Release. By using any of the services, communication, contact and social media offered by COUNTRY PET RANCH, you agree to allow COUNTRY PET RANCH and any of their affiliates to use your Pet's name and any image or likeness of your Pet(s) taken while at COUNTRY PET RANCH, in any form or format, for use at any time, in any media, marketing, advertising, illustration, trade or promotional material. This provision is binding on you, and all of your successors, and assigns, heirs, and legal representatives.

3. Personal Property. COUNTRY PET RANCH will not be liable for any lost, stolen or damaged personal property belonging either to you or your Pet(s). If your Pet(s) causes any personal property damage to COUNTRY PET RANCH, the site(s) where Pet Sitters services are provided, another Pet or otherwise, you will be liable for the full cost of all treatment, repairs and replacements.

4. Fees. You must pay for all services and products by credit card, cash or check. All payment is due at the time you pick up your Pet(s) from COUNTRY PET RANCH or at the time services are rendered by Pet Sitters. You give your express permission for COUNTRY PET RANCH to charge any credit card you provided for unpaid services or products upon the date services were supposed to have been completed. You further agree to pay any collection costs and the cost of any returned or challenged check or debit charges.

5. Acknowledgement of Policies. You explicitly acknowledge that COUNTRY PET RANCH is an unmanned facility from the hours of 6:00 PM to 7:00 AM. You accept that your pet will be on his own at COUNTRY PET RANCH during these hours daily, including on nationally recognized holidays when fireworks, parades or other events occur which may frighten or otherwise disturb your pet, and you fully accept and assume all risk and responsibility for any damage your pet may do to himself or COUNTRY PET RANCH.

6. Aggressive Dogs. COUNTRY PET RANCH does not tolerate aggressive dogs and reserves the right to not board, not admit into day care, transfer or remove your Pet(s) from COUNTRY PET RANCH or to remove or transfer pet sitters from assigned jobs in COUNTRY PET RANCH's sole discretion. Your Pet(s) may be separated from other pets or asked not to return to COUNTRY PET RANCH if he/she exhibits aggressive or other unacceptable behavior. Such determinations will be made at the sole discretion of COUNTRY PET RANCH.

7. Abandoned Dogs. No Pet(s) may be left at COUNTRY PET RANCH after the scheduled pick up time without communication and payment from you or your authorized representative. If your Pet(s) is left at COUNTRY PET RANCH without any contact, instruction, notification and payment regarding its pick up from you or your authorized representative, your Pet(s) will be deemed "Abandoned" at 6 PM on the fifth (5th) day after the scheduled pick up date. If you Abandon your Pet(s) at COUNTRY PET RANCH, COUNTRY PET RANCH will become its legal owner and guardian. COUNTRY PET RANCH will, in its sole discretion, determine whether to rehome the Pet or relinquish it to a shelter or rescue of COUNTRY PET RANCH's choice. YOU FULLY UNDERSTAND AND AGREE THAT IF YOU ABANDON YOUR PET AT COUNTRY PET RANCH, YOU MAY BE UNABLE TO RETRIEVE POSSESSION OF YOUR PET(S) AND WILL HAVE NO RECOURSE AGAINST COUNTRY PET RANCH.

8. Duty to Disclose. You must disclose on a continuing basis, any and all medical or other conditions, including but not limited to personality concerns or behavioral incidents that in COUNTRY PET RANCH's sole discretion, may affect, limit or prevent your Pet's ability to participate in any COUNTRY PET RANCH activity or Pet Sitters service.

9. ACCEPTANCE AND ACKNOWLEDGEMENT OF RISK. YOU FULLY UNDERSTAND THAT: (a) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS, AS WELL AS BETWEEN PET(S) AND OTHER PETS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR PET; AND (b) THERE MAY BE OTHER RISKS NOT KNOWN TO YOU OR COUNTRY PET RANCH, NOR READILY FORESEEABLE AT THIS TIME (COLLECTIVELY, "RISKS"). YOU FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF YOUR PET'S PARTICIPATION AT COUNTRY PET RANCH, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF OR CAUSED BY YOUR PET(S). "SICKNESS" INCLUDES ANY ILLNESS NOT LIMITED TO BORDETELLA (KENNEL COUGH), BLOAT, OR ANY OTHER FORM OF DISEASE.

10. Veterinarian Liability and Care. COUNTRY PET RANCH will have the right to obtain medical treatment for your Pet(s), if, in COUNTRY PET RANCH's sole discretion, it appears that your Pet(s) may be ill, injured or exhibits any other behavior that would reasonably suggest that your Pet(s) may need medical treatment. COUNTRY PET RANCH will first attempt to notify you of the need or option for veterinary care, but will have the right to seek veterinary treatment from any licensed veterinarian or emergency veterinary facility, if it is unable to reach you. YOU WILL BE FULLY RESPONSIBLE FOR ALL COSTS RELATED TO ANY MEDICAL TREATMENT, INCLUDING WITHOUT LIMITATION, THE COST OF ANY TRANSPORTATION FOR THE PURPOSE OF SUCH TREATMENT. You must also provide veterinary records to COUNTRY PET RANCH in order to use their services.

11. WAIVER, RELEASE AND INDEMNIFICATION. YOU HEREBY AGREE TO EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND COUNTRY PET RANCH, their invitees, owners, officers, directors, employees, contractors, volunteers, agents, representatives, lessors, and all others having an interest in any COUNTRY PET RANCH party (collectively, the "Releasees") from and against ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, ATTORNEY'S FEES, EXPENSES OR DEMANDS OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in any way to (i) any act or omission of the Releasees (ii) your Pet's participation at any COUNTRY PET RANCH, services provided by Pet Sitters, or otherwise. YOU AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THE REMAINDER OF THIS AGREEMENT WILL REMAIN IN FULL FORCE AND EFFECT; YOU AGREE THAT THIS RELEASE IS BINDING ON YOU AND YOUR SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. YOU ALSO EXPRESSLY AND FOREVER RELEASE COUNTRY PET RANCH FROM ANY DUTY TO PROTECT YOU OR YOUR PET FROM INJURY OF ANY KIND, AND AGREE THAT ANY IMPLEMENTATION OF SAFETY PRECAUTIONS BY COUNTRY PET RANCH WILL NOT WAIVE COUNTRY PET RANCH'S RIGHT TO BE INDEMNIFIED AS PROVIDED HEREUNDER, AND SUCH PRECAUTIONS WILL NOT ALTER THIS RELEASE.
